

The Gym Group – Additional terms & conditions for "Workout 4 a win" challenge – May 2022

Introduction

The following additional terms apply to the "Workout 4 a win" challenge (the "Challenge") running between 29th April 2022 and 30th June 2022.

By entering the Challenge, you are accepting all the terms and conditions in this document. You should only enter the Challenge if you have read and accepted all the applicable terms and conditions.

Conditions of entry

Entry to the Challenge is by invitation only and requires the following entry criteria to be met:

- Invitations will be sent to qualifying members by email. The email will be from The Gym Group and will have a subject line "Workout 4 a win" or "Make 4 visits and get rewarded"
- To complete their entry, the member needs to click the button to opt-in on the email invitation by the date specified in the email.
- To become eligible for a reward, the member must make qualifying visits to The Gym Group on at least 4 separate days within the dates specified in the email, using their PIN or the contactless access system in The Gym Group's mobile app.
- Once the member has opted into the Challenge and subsequently made the minimum number of qualifying visits, they will be sent an email within 30 days of their final qualifying visit with instructions on how to claim their reward.
- In order for a member to claim their reward they follow a designated reward claim journey within the allotted time frame.
