

The Gym Group – “Beat the Awks” competition – September 2021

Introduction

The following additional terms apply to the “Beat the Awks” competition (the “Competition”) running between September 2021 and December 2021. By entering the Competition, you are accepting all the terms and conditions in this document. You should only enter the Competition if you have read and accepted all the applicable terms and conditions.

Conditions of entry

Entry to the Competition is by invitation only and requires the following entry criteria to be met:

- Invitations will be sent to qualifying members by email. The email will be from The Gym Group and will have a subject line “*Chunkz has set you a challenge*”.
- To complete their entry, the member needs to make qualifying visits to The Gym Group on at least 3 separate days before the end date specified in the email, using their PIN or the contactless access system in The Gym Group’s app.
- Once the member has made the minimum number of qualifying visits, they will be sent an email confirming their entry into the draw to win a £100 Amazon Gift Card.
- Entries from members who do not have a qualifying fixed term student membership product, or do not meet the other conditions of entry, will not be accepted.

Other terms
