The Fine Print

We've set out below the terms and conditions for our 'Ultimate Gym Bundle Giveaway: April 2022.'

1. The Promotors

 1.1. The Promoters are The Gym Group Limited (trading as The Gym Group) of 5th Floor, OneCroydon, 12 - 16 Addiscombe Road, Croydon, CR0 0XT (Company number 05659669) and Boohoo.com UK Limited of 49/51 Dale Street, Manchester, M1 2HF (Company number 05723154).

2. Eligibility

- 2.1. This Prize Draw is open to individuals in the UK, aged over 16 years or over, except for employees of the Promoter, their immediate family, sponsors of the Prize Draw and their employees who are directly associated with the administration of the Prize Draw.

3. The Competition

4. How to enter

5. Winner selection and contact

- 5.4. If any Winner fails to provide their Details to the Promoter within 48 hours of the Promoter

contacting the winner and asking them to provide the Details in accordance with clause 5.3 then the

Promoter acting in its absolute discretion may:

- 5.4.1. make further attempts to contact that Winner; and/or
- 5.4.2. withdraw the Prize from that Winner.
- 5.4.3. If the Prize is declined by a Winner or is withdrawn from a Winner by the Promoter, the declining or forfeiting Winner will continue to be subject to the provisions of these Terms and Conditions; and the Promoter may offer the Prize to a new Winner by random selection in accordance with this clause 5.3.

9. Use and display of Entries and copyright

10.16. The Winners agree to indemnify and keep indemnified the Promoter, its group of companies and their officers, employees and agents from and against all liabilities, losses, damages and expenses (including legal and other professional fees) arising out of or in connection with any allegations or claims resulting directly or indirectly from: 10.17. their Entry into this Prize Draw; and/or 10.18. their receipt and use of any Prize.

11. General

No failure or delay by a party to exercise any right or remedy provided under these Terms and Conditions or by law or any abandonment of any such right or remedy shall constitute a waiver of that or any other right or remedy, nor shall it preclude or restrict the further exercise of that or any other right or remedy.
- 11.14. No single or partial exercise of such right or remedy shall preclude or restrict the further exercise of that or any other right or remedy.
