

## Stop the Clock Gym Challenge – Terms & Conditions

### Introduction

The following additional terms apply to the 'Stop the Clock Gym Challenge' ("the competition") valid between 00:01 Monday 17<sup>th</sup> January 2022, until 23:59 Friday 31<sup>st</sup> January 2022.

By entering the Competition, you are accepting all the terms and conditions in this document. You should only enter the Competition if you have read and accepted all the applicable terms and conditions.

### How to enter

- Speak to a member of staff and ask them to observe you completing a 250-meter row on site at one of The Gym Group's locations.
- The member of staff will turn the computer screen over (hiding it from your view) and you will keep rowing until you think the distance has reached 250 meters.

### The Fine Print

We have set out below the terms and conditions for our competition.

1. The Promoter is The Gym Group Limited of 5th Floor, One Croydon, 12 - 16 Addiscombe Road, Croydon, CR0 0XT (Company number 05659669).
2. Entries will be open from 00:01 Monday 17<sup>th</sup> January 2022, until 23:59 Friday 31<sup>st</sup> January 2022.
3. To be eligible for entry you must be a resident in the UK and be 16 years or over, be a DO IT, LIVE IT or Student member (Bring a Friend attendees are not eligible).
4. Entries are limited to one per person.
5. To win, the rower must finish exactly on 250-meter and must be confirmed and verified by the member of staff and the site management
6. The winner will receive one month of free membership credited to their account for the month of March 2022. This cannot be transferred to another member.
7. Once the winner is notified, the membership must be claimed within 3 months.
8. The prize pool is limited to 15 correct entries per gym location and if this amount is exceeded the competition will end.
9. No cash equivalent is available – the prize membership may not be transferred or redeemed for cash.
10. The Gym Group Limited reserves the right to disqualify any entries which it deems, at its sole discretion, to contravene the spirit of the giveaway and any prize if awarded will be cancelled.
