2. Offer Details

1. The Offer entitles Eligible Customers to:
 1. a 10% discount on the monthly membership fee; and
 2. no joining fee.
2. The Offer applies to selected monthly membership products, including Standard and Ultimate memberships.

2. annual saver or fixed-term memberships;
